The Aging and Long-Term Services Department (ALTSD) is committed to the fundamental principles of the State-Tribal Collaboration Act (STCA) through building partnerships with tribal leaders on a government-to-government basis and supporting tribal senior and adult day services centers located on respective tribal land bases. Addressing the needs of all tribal elders is one of the agency's top priorities in accordance with Subsection A of Section 3 [11-18-3 NMSA 1978] of the STCA.

At the heart of ALTSD's belief is that New Mexico's older adults and adults with disabilities have the right to remain active participants in their communities, to age with respect and dignity, to be protected from abuse, neglect, and exploitation and to have equal access to health care. ALTSD is a leader in developing programs and building partnerships that support lifelong independence and healthy aging.

Within ALTSD is the Office of Indian Elder Affairs (OIEA) which advocates for funding, services, resources and healthy aging on behalf of New Mexico's 23 Tribes, Pueblos & Nations senior centers and adult day services centers. Additionally, OIEA assists tribal elders, their caregivers and families, by providing information on available support services and resources.

Annually, ALTSD's metrics identify how to further support New Mexico's Tribes, Pueblos & Nations and to improve upon the Agency's divisions and programs effectiveness. This report provides State-Tribal Collaborations Act mandated relevant information and an overview of the Aging and Long-Term Services Department, its organizational structure and illustrates how tribal eldercare centers operate within the National Aging Network.


### ALTSD Mission

Providing accessible, integrated services to older adults, adults with disabilities, and caregivers to assist them in maintaining their independence, dignity, autonomy, health, safety & well-being, thereby empowering them to live on their own terms in their own communities as productively as possible.



ALTSD was created in 2004 by the New Mexico State Legislature. ALTSD operates New Mexico's Aging and Disability Resource Center (ADRC) and the State Ombudsman Program. ALTSD is also the designated state agency for Adult Protective Services, State Agency Unit on Aging, and is an active partner in New Mexico's Aging Network. Though these divisions, ALTSD supports aging in place by providing services in homes and communities, establishes programs and offers resources to support caregivers, combat senior hunger, encourage healthy and productive aging, and build and sustain capabilities to meet emerging needs and challenges.

In FY24, the New Mexico Legislature and Governor Michelle Lujan Grisham appropriated \$89,402,700 to ALTSD to support developing and administering a multi-year state plan that advocates for and provides assistance to older residents, their families and adults with disabilities. Of this amount, OIEA was allocated \$6.9MM to provide supplemental funding to NM's Tribes, Pueblos and Nations providing senior services. ALTSD, which serves as a State Unit on Aging (SUA) agency, within the National Aging Network, provides funding through New Mexico's four Area Agencies on Aging (AAA's) and the six Planning and Service Areas (PSAs) designated to these AAA's. The six PSA's, develop programs to meet the specific needs of older persons residing in the PSA areas and funding for programs is allocated to each PSA based on the number of persons over the age of 60 in the state, and 50+/55+ within NA Tribes, Pueblos, Nations, residing in these designated PSA's.

## **AGENCY OVERVIEW**



This section will provide a general understanding of the national "Aging Network" in connection to New Mexico, ALTSD, OIEA and New Mexico's Tribes, Pueblos & Nations. Note: In the "Aging Network", senior and adult day services centers are referred to as "*Providers*."

### The Aging Network

The Older Americans Act of 1965 (OAA) established a national network of federal, state, and local agencies to plan and provide services that help older adults to live independently in their homes and communities. This interconnected structure of agencies is known as the Aging Network and is headed by the Administration for Community Living (ACL) which is a federal agency within the U.S. Department of Health and Human Services. The Aging Network includes 56 State Unit Agencies on Aging (SUA), 622 Area Agencies on Aging (AAA), and more than 260 Title VI Native American aging programs. New Mexico's Aging Network is comprised of:

- ALTSD is New Mexico's "State Units on Aging" (SUA). State Units on Aging (SUAs) are the
  designated agencies at the state level responsible for developing and administering a multiyear state plan that advocates for and provides assistance to older residents, their families and
  for adults with physical disabilities. This assistance is provided through the state's established
  Area Agencies on Aging (AAA).
- Area Agencies on Aging (AAA) An AAA is a public or private nonprofit agency designated by a
  state to address the needs and concerns of older persons. AAAs coordinate and offer services
  that make it possible for older individuals to choose the services and living arrangements that
  suit them best. The AAA's are responsible for a geographic area known as a Planning and
  Service Area (PSA).
- Planning and Service Areas (PSA) There are six PSA's in New Mexico which make up the ALTSD Aging Network. This network includes two federally recognized AAA's and two Native American AAA's that oversee the collective six PSA's and the Providers within these locations.

### **OIEA Mission**

Coordinate and enhance a system of services that empower American Indian Elders with support and resources to live a healthy lifestyle with joy, respect, and dignity in their tribal communities.

### **OIEA OVERVIEW**

Per N. M. S. A. 1978, § 9-23-10, OIEA manages the Indian Area Agency on Aging (IAAA), supports the efforts of the Navajo Nation Department of Health's Division of Aging and Long-Term Care Support (DALTCS), and serves as the office within ALTSD to support New Mexico's 23 Tribes, Pueblos & Nations in the development of a comprehensive and coordinated service system of tribal senior centers and adult day services centers.

OIEA's general operational functions include: advocating for and facilitating state general funding allocations, IAAA/NAAA contract management of state general funds, technical assistance, advocacy, and training.

### IAAA Senior Centers & Adult Day Services Centers (Pueblos & Apaches)

- 5181 elders utilize services
- There are **21** senior centers
- There are **4** adult day service centers

### NAAA Senior Centers (Navajo Nation)

- 4104 elders utilize services
- There are **29** senior centers

### Services & Resources

Support and assistance offered by tribal senior & adult day services centers may include:

- In-Center Meals
- Home-Delivered Meals
- Case Management
- Transportation
- Homemaking/Housekeeping
- Personal Care
- Respite for Caregivers
- Physical Fitness & Exercise





In Spring 2023, New Mexico's Tribes, Pueblos & Nations Providers, which had been severely impacted by the COVID-19 pandemic, began re-opening. The tribal senior and adult day service centers would face the challenges of community loss impacts, facility maintenance, under staffing, applicant pool challenges, training needs, safety concerns and encouraging qualified community members to return or begin to take advantage of the senior or adult day centers services. As FY24 began, OIEA, on behalf of the senior & adult services centers, focused on initiating and navigating the centers return to standard operating processes and assessing the barriers the tribal eldercare centers were then facing. Forging solutions postpandemic has been a priority and is addressed carefully as each tribe is diverse in culture, language, landscape and community, for these reasons, unique approaches specific to each tribe are taken into consideration. Throughout this reintegration process, ALTSD and OIEA continued to develop programs, streamline provider processes, and build connections upon the collective work that is being accomplished by tribal administrations, tribal senior and adult day services centers, the Indian Affairs Department and Native American elder advocacy organizations.



### Pueblo Pintado Senior Center Grand Opening

January 18, 2024 Pueblo Pintado, New Mexico

This was a capital outlay funded project. The center is operated by the Navajo Area Agency on Aging (NAAA) / Division of Aging and Long-Term Care Support (DALTCS)



ALTSD divisions that collaborate with tribes, through various programs, are Office of the Secretary, Consumer & Elder Rights, Aging Network Division, Office of Indian Elder Affairs, Adult Protective Services, Administrative Services Division, External Affairs, General Counsel and Information Technology.

- OIEA, on behalf of ALTSD, supports and collaborates with New Mexico's tribes through the agency's divisions, programs, resources, funding opportunities, and capital outlay.
- ALTSD divisions serve, through direct services or resources, individual New Mexico Native
   American elders who may not be residing on reservations yet make contact with ALTSD through
   publicly published department information.
- Programs include:
  - New MexiCare, which provides financial assistance and training to caregivers
  - New Mexico Grown which ensures freshly harvested local foods become a staple in the diets of New Mexico's seniors.
- ALTSD elevates the quality of care of the state's Providers to include:
  - Offering advocacy through the Long-Term Care Ombudsman volunteer program
  - Providing intervention through the agency's national award-winning Adult Protective Services.
  - Housing the state's Aging and Disability Resource Center, which offers options counseling, education, and connection to resources.
- Capital Outlay appropriations are made to ALTSD to fund senior center projects, statewide to both local government and tribal governments. Projects include, new construction and renovations including equipment, and for the purchase of vehicles.
  - Applications are submitted through the application database.
  - The Capital Outlay Bureau (COB) also tracks all capital appropriations and fiscal information, monitors the expiration dates of capital appropriations, and ensures timely reversions of expired appropriation balances.
  - Staff provides training and technical assistance to local or tribal governments regarding planning, project management and administration of capital project appropriations.

ALTSD's maintains and continues efforts to implement the policy set forth in Subsection A of Section 3 of the State-Tribal Collaboration Act. At times, unique challenges are presented based on a range of tribal diversity factors which may include location, the digital divide, staffing. OIEA's implementation of best practices and solutions while recognizing and respecting sovereignty remains a primary consideration. ALTSD as a department, and through OIEA, follows the guiding principles for improving and maintaining tribal partnerships which are inclusive of recognizing and respecting sovereignty, frequent and regular communications, and overall collaborative efforts in addressing the unique needs of New Mexico 23 Tribes, Pueblos and Nations.

• Certification by the state personnel office of the number of managers and employees of each state agency who have completed the training required by Subsection B of this section.

ALTSD staff are required to attend, participate and complete "The Building Cultural Equity Training" offered through the State Personnel Office in conjunction with the Indian Affairs Department. In FY24, 13% staff members completed the training.

### Capital Outlay

In FY24, \$34.8 MM was appropriated, and overall, since 2021 over \$23 MM in capital outlay projects are pending throughout the Tribes, Pueblos and Nations.

- Appropriations are made to ALTSD to fund senior center projects, statewide to both local government and tribal governments. Projects include, new construction and renovations including equipment, and for the purchase of vehicles.
- The application process is open from February May and applications are submitted through the online application database.
- The Capital Outlay Bureau (COB) tracks all capital appropriations and fiscal information, monitors the expiration dates of capital appropriations, and ensures timely reversions of expired appropriation balances.
- Staff provides training and technical assistance to local or tribal governments regarding planning, project management and administration of capital project appropriations.
- ALTSD provided a recommendation of projects for consideration in the upcoming legislative session.

Moreover, all ALTSD employees have been notified that FY25 mandatory department training courses includes "Building Cultural Equity with Native Nations (SoNM-1653)" and ALTSD STCA consultation, collaboration and communication policies shall be disseminated to all new and current employees as part of new employee orientation as well as continued employee training.





### Accomplishment #1: Advance OIEA Operations

In FY24, OIEA focused on assessing barriers the Tribal Provider centers were facing post pandemic. Evaluation of these challenges and changes, provided an opportunity to reevaluate methods, tools, and efficiencies to support and better equip the Tribal Provider to meet those challenges and identify sustainable solutions.

### Operations advancement included:

- Two Native American women were appointed to lead OIEA operations.
- Reinstated and redirected the SOW for the AmeriCorps Vista Project for an additional \$25,000 grant to fund a needs assessment initiative OIEA VISTA Project: Identifying Tribal Eldercare Needs for Supplemental Services.
- Deployment of NM Grown program to 6 tribal providers during the FY24 3rd & 4th quarters ensuring local foods availability for meals being served.
- Reinstated stalled capital outlay requests for Taos Pueblo and Pueblo of Laguna
- At end of Q2 (December 2023), only 30% of FY24 Tribal Provider IGA allocations were expended. After a significant push by Director Sanchez, Q3 expenditures increased to 70% (March 2024). Q4 final expenditures were 93%, representing a 1% gain over FY23.

For consumers, the advantage is improved well-being, welfare, and independence.

### Goal #1: 100% Allocated Funding Expenditures

OIEA administers the IAAA & NAAA Intergovernmental Agreements (IGAs). The IGAs (contracts) are the government-to-government agreement for the state general funds allocated as supplemental funding, and other funding opportunities such as the Senior Services Expansion and NM Grown, to support tribal senior & adult day service centers. OIEA manages the IGA's in collaboration with Tribal Leaders and their Tribal Provider managers/directors by monitoring timely responses of contract reporting responsibilities and monthly reimbursement requests.

- OIEA will expand it's efforts to aid 100% IGA expenditures.
- ALTSD will continue with early IGA distribution to allow for additional time for Tribal Administrative review.
- Fiscal staff and tribal leaders will be invited to meetings (in addition to Tribal Provider manager/directors)
- 1:1 meetings, monthly phone calls and deadline reminders
- Mid-fiscal year funding balance review to assess possible IGA budget reductions will be implemented.
- Applicable ALTSD divisions are available to support Tribal Providers with training, service development or service improvement.
- Applicable ALTSD divisions, with OIEA, will seek to identify and provide relevant technical
  assistance for Tribal Providers to support timely reporting responsibilities submission and
  monthly funding reimbursement requests.
- The Capital Outlay Bureau will continue to provide funding opportunities and OIEA will continue to guide Tribes, Pueblos and Nations to expend 100% of the funding allocation.

## FY25 GOALS & OBJECTIVES



### Goal #2: Advance Communication and Outreach

OIEA is furthering its communication strategy with Tribal partners. These efforts include:

- Increased tribal site visits.
- ALTSD Capital Outlay application announcements and funding status updates.
- Development of an annual calendar including relevant timelines, workshops, trainings, and information about the capital outlay funding process.

### Goal #3: Implement FY25 Initiatives

Over the next fiscal year, there are several areas where OIEA will be prioritizing efforts: Gaps & Needs Analysis, Capital Outlay Assessment, New Mexico Grown Tribal Participation and Service Expansion

### Gaps and Needs Analysis

ALTSD will utilize data collection tools and methodologies for the purpose of establishing a baseline of information that will lead to formation of a strategic plan for ALTSD and OIEA through the AmeriCorps VISTA Project: Identifying Tribal Eldercare Needs for Supplemental Services. This analysis aims to identify operational needs of Tribal Provider facilities and services that are associated with any barriers to successful operations and meeting the needs of the tribal elders within their communities. Findings will be shared with participating Tribes, Pueblos and Nations.

### **Capital Outlay Assessment**

ALTSD will begin a statewide assessment of all senior center buildings for the purpose of prioritizing capital outlay recommendations to the New Mexico Legislature for funding and long-term planning. ALTSD anticipates this assessment will take nearly a year to complete but will provide invaluable information that will reduce the administrative burden for tribal and local governments in the future. Tribes, Pueblos and Nations are encouraged to participate.





# FY25 GOALS & OBJECTIVES



### **New Mexico Grown Tribal Participation**

NM Grown is a program that works with local farmers, ranchers, and food businesses to connect them to people and organizations right here in our state. When local food producers can provide their fruits, vegetables, and meat to preschools, K-12 schools, senior centers, adult day care centers and food banks, it helps communities stay healthy and self-reliant.

NM Grown supports publicly funded meal programs by highlighting healthy food options and increasing access to fresh locally grown and produced foods for institutional and food bank buyers. The program strengthens purchasing relationships with food producers, creating sustainable market opportunities and healthy communities. Through this work, NM Grown can empower children, older adults, and families to make informed food choices while strengthening the state's local economy and contributing to vibrant communities.

FY25 New Mexico Grown Tribal allocation's total \$245,311. There is participation by 16 Pueblo Senior Centers, 3 Pueblo Adult Day Services Centers, and 29 Navajo Senior Centers for a total of 48 centers. In FY24, only 6 senior centers participated.

### **Service Expansion Initiative**

ALTSD believes that a strong Area Agency on Aging provider network is essential to the health of older adults in New Mexico.

The goal of this initiative is to strengthen the Area Agency on Aging provider network and capacity.

The purpose of the Senior Services Expansion Initiative is to increase the number of Case Management services, Transportation services, Legal services and Community Activity services offered by Area Agency on Aging Providers with an objective of increasing the number of customers served and units of services in Fiscal Year 2025.
